Limited Two-Year Warranty

This machine and equipment are **WARRANTED** by LEMMER SPRAY SYSTEMS, LTD. for a total period of **TWO YEARS** from the **ORIGINAL** purchase date by the **ORIGINAL PURCHASER**. Proof of purchase to be included and warranty card filed with California Tan® by completing and mailing the form below. This warranty is in lieu of all other express warranties, any **WARRANTY** implied by law, including but not limited to implied warranties of merchantability or fitness, is excluded to the maximum extent permitted by law and, if not excludable, it is limited to the duration of the express Warranty. No representative or person is authorized to extend this Warranty or to create for LEMMER SPRAY SYSTEMS, LTD. any other liability in connection with the sale of any LEMMER SPRAY SYSTEMS, LTD. product.

LEMMER SPRAY SYSTEMS, LTD. upon examination of the machine/equipment will replace or repair at their discretions any defects in material or workmanship.

Limitation of Damages

In no event shall California Tan be liable for consequential damages for breach of this warranty. Some States do not allow the exclusion of limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to the buyer. However, to the maximum extent permitted under applicable law, the only rights and remedies shall be to obtain a replacement for any defective product. This warranty gives you specific legal rights and you may also have other rights which vary State to State.

Warranty Coverage

California Tan warrants LEMMER SPRAY SYSTEMS, LTD. spray guns to be free of all defects in material and workmanship for two years from original purchase date. This warranty extends to the original buyer only.

With the period of this warranty, California Tan will provide replacement parts or a replacement refurbished spray gun, free of charge; any part or spray gun proving defective in material or workmanship. If a replacement spray gun is needed while California Tan examines buyer's spray gun, credit/debit card information will be required. This will insure payment if buyer's spray gun is not covered by the warranty. Also, if the buyer's spray gun is not returned within 30 days of receiving the replacement spray gun, the credit/debit card will be charged.

All expenses related to replacing or parts to fix a defective part under this warranty shall be assumed by California Tan except for the following expenses, which shall be assumed by the buyer.

Warranty Exclusions

This warranty does not cover problems caused by:

1. Disassembled equipment or modifications to the equipment
2. Improper care
3. Water damage to electrical parts
4. Incorrect voltage connection
5. Misuse
6. Improper cleaning (i.e. cleaning with any cleaner, not cleaning)
7. Neglect or damage due to user error

LEMMER SPRAY SYSTEMS, LTD. shall not be liable for any consequential, incidental, or special damage of any kind directly or indirectly resulting from breach of any express or implied Warranty
